But what authority do you have to get her name and address?

At the moment sir what we're dealing with as a littering offence is covered by the Environmental Protection Act of 1990. Within that it was actually a separate offence of failing to provide your name and address when required to do so. Because we went as the offence, we are actually requiring you to provide your name and address as a separate offence if you don't provide it to us. Now, at the moment, the fixed penalty notice as far littering, that can be dealt with by way of the fixed penalty. If you refuse to provide your name and addresss, that's a separate issue. It can be a case report to the procurator fiscal. And at the moment, we would need to call Police Scotland. Now for a littering offence, do we really want to escalate it to calling Police Scotland down here?
